SPLC & VAYLA jointly investigated enrollment & registration requirements of every New Orleans public school for compliance with federal law.

We looked for two red flags:

- 1. Did the school request a student's Social Security number without any stated exception or qualifier?
- 2. Did the school request a parent's driver's license or state ID without allowing for alternate forms of photo ID?

If either or both conditions appeared on enrollment paperwork, we considered it problematic with regard to federal civil rights law.
