**PLAINTIFFS’ REPLY TO DEFENDANTS’ RESPONSE TO THE
COURT’S PHASE 2A ORDER ON CORRECTIONAL STAFFING

both the Savages' correctional staffing analysis and the Warren Averett Report. *Braggs v. Dunn*, 2:14-cv-601-MHT, 2018 WL 7106346 at *1 (M.D. Ala. Feb. 20, 2018). Plaintiffs do not object at this time to BCOs filling some posts previously designated for COs, as recommended by Warren Averett. However, the Savages' correctional staffing analysis makes no mention of BCOs. *See* Doc. 1813-1. Meg Savages' December 20, 2019 declaration states only that BCOs may fill all CO posts "except for those posts requiring firearms." Doc. 2703-4 at ¶ 10. The Savages'
